

MEMBERSHIP PROCEEDURES

According to Section IV of "LELA Articles", Article 7, LELA has two membership categories:

- 1) Voting Members: *Effective Members*
- 2) None voting Members: a) Corporate Members, (b) Honorary Members, and (c) Provisory Members.

Honorary Members are nominated by the Administrative Committee; no application form is necessary.

Corporate members shall send a letter of interest to <u>info@lela-lb.org</u>. The Administrative Committee will review the request for membership and communicate the information concerning membership fees.

Effective and Provisionary members

Online application forms only apply to *Effective and Provisionary members* (FORM A- EFFECTIVE MEMBERS; FORM B- PROVISIONARY MEMBERS).

Completed forms are sent to info@lela-lb.org

According to LELA Articles, Article 8, each Membership Application shall include:

- Completed form
- Letter expressing applicant's intention to become affiliated with LELA
- Judicial Police record (سجل عدلی)
- Copy of Identity Card (صورة عن الهوية)
- Curriculum Vitae (C.V.)

The Administrative Committee will review the application, contact the applicant and confirm acceptance and provide membership payment details.

Application fees 25,000 LBP (Only once upon registration, membership fees are settled annually)

Fist Category (Voting Members): EFFECTIVE MEMBERS

This category includes:

- Professionals holding university degrees from sections, branches, and academic programs
 of landscape architecture / engineering in Lebanon or from another country provided they
 obtain the equivalence thereof from the Lebanese authorities.
- Landscape professionals having an experience of at least ten years in this field.
- Landscape academics teaching core landscape courses, for example landscape design studio, landscape history, landscape horticulture, etc..., with teaching experience of at least ten years.

EFFECTIVE MEMBER ANNUAL SUBSCRIPTION FEES: 150,000 LBP



Second Category (Non-Voting Members)

This category includes (1) CORPORATE MEMBERS, (2) HONORARY MEMBERS, (3) PROVISORY MEMBERS.

- 1) Corporate Members: scientific, educational and professional enterprises, association's and companies, directly associated with landscape architecture construction, professional, commercial, and/ or industrial organizations wishing to promote or support the objectives of LELA. This category of members doesn't have voting rights as mentioned above; their annual membership subscription that will be determined by the Administrative Committee.
- 2) **Honorary Members**: members whose affiliation candidature is proposed by the Association in gratitude to their imminent contribution to the profession regardless as to whether they hold an official degree or not in this field.

3) **Provisory members**: Students from sections, branches and programs or curriculum of landscape architecture/engineering study of any kind in the universities of Lebanon or any other country. These members are provisory until the completion of their studies and the achievement of the relevant diploma. Provisory Members don't have voting rights as mentioned above; however, they must settle their annual membership subscription that will be determined by the Administrative Committee.

PROVISORY MEMBER ANNUAL SUBSCRIPTION FEES: 50,000 LBP

Membership Procedures (Article 7.4.1)

Individuals desiring affiliation to the Association as effective members' category, honorary members or corporate members and must fulfill following criteria:

- Are Lebanese citizens or foreigner provided that for each foreign member there are four Lebanese members.
- Have completed the 20 years of age.
- Enjoy the civil rights and should be non-condemned by any crime or odious misdemeanor.
- Abide by the Articles of the Association, the Association Bylaw and acting for the realization of its objectives

Corporate bodies desiring affiliation to the association must:

- Be Lebanese or foreign citizen provided that for each foreigner there are four Lebanese citizens.
- Abide by the Articles of Association, the Association Bylaws and working for the realization of its objectives
- Delegate in writing specifically for this purpose, an individual to represent it towards the Association for presenting the membership application, and later in the association if its membership is accepted.
